ENTRY FEE: \$200.00 PER TEAM

Team Member Handicaps must be within (8) strokes of each other. ONLY C.G.A. or U.S.G.A. HANDICAPS or HANDICAPS VERIFIED BY LOCAL GOLF PRO OR CLUB MANAGER ACCEPTED. THE TOURNAMENT COMMITTEE RESERVES THE RIGHT TO ADJUST INDIVIDUAL PLAYER HANDICAPS.

Prize money is approximately \$1000.00 per flight depending on number of teams entered. Four handicapped flights. Five places paid per flight depending on the number of entries in each flight.

THERE WILL BE A TEAM EVALUATION FRIDAY, AUGUST 19, 2011 AT 6:00 P.M. AT THE WALSENBURG CLUBHOUSE. THE MONEY WILL STAY IN EACH FLIGHT.

THERE WILL BE A FREE PRACTICE ROUND FRIDAY, AUGUST 19, 2011 AT THE WALSENBURG GOLF COURSE STARTING AT 11:00 A.M. THERE WILL BE NO EXCEPTIONS TO THE STARTING TIME FOR THE PRACTICE ROUND.
